CIRCULAR

Further, the aforementioned social media groups are being used as platform for venting personal grievances and grudges against the Management of the Corporation, often using derogatory language. Such activities are having adverse effect on the image of the organization in general and JCI officials in particular.

In view of the prevailing circumstances, all officials are hereby cautioned against initiation of any such groups and posting of any derogatory comments against the Corporation or its Management in any social media. Such acts will be seriously viewed by the Management and will be referred for critical investigation, if the management thinks fit and the same may lead to disciplinary action as per CDA rules of the Corporation.

It may further be informed that only the below mentioned what's app groups are authorized by the Management

2. JCI Operations
3. JCI Wisdom

Apart from the above, any other social media group / page discussing affairs of the Corporation, will be considered unauthorized and administrators and members of such groups are liable to disciplinary action by the Management.
