
They will be on probation for a period of 6 (six) months from the date of joining the new post. At the end of this period, if their services are not found satisfactory, their case will be considered for reversion / extension of the probation period as may be deemed proper by the competent authority.

They will have to be computer conversant by 6 (six) months and acquire the working knowledge in Hindi. They may be assigned any additional task or responsibility by the management for the interest of the Corporation.

They must intimate their acceptance of promotion with posting as stated above and a clear unconditional acceptance of promotion is to be submitted within three days from the date of receipt of this order, failing which it would be assumed that they are not interested for the said promotion and for such refusal to accept promotion without sufficient valid reasons, the Competent Authority may not consider them for promotion for one year in terms of Office Circular No.JCI/1(4)/82-Admn.1 dtd. 05.05.82. They must join their new places of posting within seven days from the date of receipt of this order.

Other terms and conditions of their services as incorporated in the offer of appointment issued to and duly accepted by them at the time of their joining this Corporation shall however remain unaltered.
