INVITATION OF TENDER FORM REGISTERED TRANSPORT CONTRACTORS UNDER THE PROVISION OF "THE CARRIAGE BY ROAD ACT, 2007" FOR CARRYING JUTE BALES FROM DIFFERENT PURCHASE CENTERS UNDER NAGAON REGION TO DIFFERENT JUTE MILLS /STORAGE GODOWNS IN AND AROUND KOLKATA AND RBHM (KATIHAR), BIHAR.

Sealed quotations are invited from established registered transport contractors for carrying jute bales (150 kgs.) from different purchase centers / storage godowns under Juria RLD to different Jute Mills / Storage godowns in and around Kolkata / Katihar.

**Procedure for Tender Submission:**

The transport contractors will have to submit their quotations in sealed envelope mentioning their full name and contact details within 15/06/2020 before 12.00 A.M. to the RLD Office, Juria. The tender papers containing two sets, **A- Technical Bid** (Appendix-1, Appndix-2) and **B- Price Bid** (Appendix – 3). These two duly filled sets are to be submitted in two envelopes super scribed **A- Technical Bid** and **B- Price Bid**. Quotations should be given by mentioning clearly section wise mill point from different storage points under this region.

**Date and Time of Tender Opening:**

Tenders will be opened on 16/06/2020 at 2.00 P.M. at the RLD Office, Juria in presence of the Tenderers or their authorized representatives.

**EMD & Security Deposit:**

All bidders have to deposit an amount of Rs.25, 000/- (Rupees Twenty Five Thousands) in favour of The Jute Corporation of India Limited, by A/C payee cheque / DD as Earned Money (EMD) along with the tender which will be converted to security deposit for successful bidders and will be refunded to unsuccessful bidders within one month from the opening of Tender. Running contractors have to enclose the Xerox copies of money receipt as proof of EMD already deposited. Such security deposit will be refunded within one month of completion of entire job by the contractor on written application. Corporation reserves the right to adjust or forfeit in partial or full of such security deposit with amount of any loss or damage during transit or any recoveries as dimmed necessary.

**Method of Selection:**

The technical bid of the tenders will be opened first and then the price bid of only those tenderers who qualify in the technical bid will be opened. Selection will be made on the basis of the lowest rates quoted by the bidder for transporting the jute bales. Transport rates mentioning section wise should be quoted clearly. Any correction or over writing in the rates quoted will be summarily rejected the tender and cancelled. Negotiation can be permitted by the Regional authority with the lowest bidder only tobring the rates in parity with local market rates.However any upward revision on quoted rates is not permissible under any circumstances at the time of finalization of tender. Thesuccessful bidder is required to accept the tender soon after his selection by the tender process failing which the EMD of the transporter will be forfeited and the transporter will be liable to pay for any loss incurred by the Corporation due to such action of his.

**Penal Clauses:**

Regional authority reserves the right to impose suitable penalty on failure in the part of contractor in following circumstances: -

- a) Non supply of lorries to carry bales within stipulated time as per requisition of Regional office or center's either over phone or written.
- b) Loss of goods by rain or other damage due to failure to cover by tarpaulin or other.
- c) Non-weighment of goods at nearest to loading point, nearest to mill points and mill point.
- d) If the difference in weight between the DPC point and outside mill point is more than 25 kgs then the value of the weight difference exceeding the permissible amount i.e. 25kgs will be adjusted from the freight charges.

**Arbitration:**

In case of any disputes between the transporter and regional authority the decision of the Regional Manager will be binding upon. However an appeal may be referred to the Head Office Authority for necessary decision on issue concerned, the decision arrived at will be final and binding on both the parties.

**Payment to Transporters:**


Payment of transport bills will be made from RLD Office on submission of necessary bills , in duplicate duly supported by consignee receipts and weighment receipts of different points. Passed amount will be paid by A/C payeecheque.

**Taxes and other duties :**

Necessary deduction will be made from the transport bills on account of applicable taxes and levies as imposed from time to time.

**Other Terms and Conditions:**

1. The rate will remain valid for Three months from the date of opening of the tender.
2. The work order will be issued to the lowest bidder or will be distributed among the lowest bidders at the discretion of Regional Manager. In case of failure to lift jute bales within stipulated period as per work order, Regional authority reserves the right to cancel the tender partly or fully or to impose suitable penalty without assigning any reason.
3. Sub-contracting of job is not allowed by any means. If any time it comes to the notice of the authority about any sub-contracting such contract will be cancelled in full immediately.
4. Any variation of contract rates due to fluctuation in fuel cost may be considered suitably at regional office but not within one month of allotment of contract based on mutual agreement.
5. Copies of valid Income Tax PAN, Professional Tax License, and proof of Business address with contact numbers have to be submitted with the tender. Failure to submit any of the above mentioned documents will lead the bid to be cancelled at the discretion of the Regional Manager.
6. Person(s) signing the tender shall clearly state the capacity on the basis of which he is or they are signing the tender (it means whether he is proprietor, Partner or Director of Business entity).
7. Any kind of loss/ damage of jute bales during transit have to be borne by the contractors. All consignments must be weighed nearest to the loading point and nearest to unloading (i.e. outside mill point) and mill point, failure to which any shortage in weigh between the points will be deducted from transport bill of the concerned transporter. No demurrage whatsoever will be paid to the transporter by JCI in case of detention of lorry/trucks in mill (unloading point).
8. During transit, stocks should be covered by tarpaulin sheet to protect the goods from rain or other damage.
