Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. The lowest bidder needs to submit the bifurcation of package rates as per car model in bidder's letterhead with GST rate (to be clearly mentioned) as applicable and excess Km and hour if not billed then actual km and hour will be added on monthly basis and will be cumulative in nature and if excess km then it will be deducted from the cumulative km. Excess Km and hour will be paid at the end of contract period subject to maximum 48,000 Km and 6000 Hrs each in case of Swift Dezire, 48000 Km and 6000 hrs in case of Honda City respectively. All the cars should be white in colour.

However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
