CIRCULAR

This is for information to all concerned that the management has approved the revised medical rules and rates like consultation fees, operation charges, bed charges, pathology/radiology/bactericlogy tests and some other tests which are listed in a statement annexed to the circular. The revised rules and rates will be effective from 01-02-2013 (If in the meantime there is any bill lying in the concerned section for processing that will be taken into account as per new rates. But once a bill is paid that will not be re-opened under any circumstances). The revised rules and rates are appended below:-

- The revised rates of Doctor's fees for consultation (indoor & outdoor treatment) / ayah and Special Nurse charges (only for indoor treatment) are listed in the Annexure.
- The recommendation of the authorized Medical Attendant for consultation to the specialist doctor does not require any longer.
 - Reimbursement of consultation fees (indoor & outdoor) / operation charge / anesthesia fees / pre-operative & post-operative visit (only for indoor treatment) is allowed on the basis of money receipt issued by the medical institution / Nursing Home / Polyclinic etc. in addition to present practice.

Income criteria for dependency:

Dependency of parents should be regarded as "wholly dependent to the employee whose monthly income does not exceed Rs.10,000/- per month". Employees concerned are requested to submit new declaration forms on dependency of parents in line with the above decision which will be deemed to have been effective from 01-02-2013.

In case of vaccines / immunization:

That "medicine/vaccine", supplied by the attending physician from his own stock may be reimbursed on the basis of money receipt/cash memo issued by the physician himself/herself in addition to present practice.

Reimbursement for package deal: The package deal for following treatment may be reimbursed as per enclosed list -

- (a) Cataract / Cornea / Glaucoma / Oculoplasty & Oncology surgery;
- (b) For Heart / Open Heart / By-pass surgery;

- (c) For ENT surgery;
- (d) For Prostate Surgery;
- (e) For Lap Chole (Gall Bladdar) / Harnia / Appendix;
- (f) For Dental Package (Surgical / Removal / Implant);
- Doctors' (Alopathy / Homoeopathy) prescribed Ayurvedic medicines may be allowed for (7)reimbursement.
- Reimbursement of medical expenditure on Cancer treatment may be allowed at actual and (8) treatment at Tata Cancer Memorial Hospital, Mumbai is also allowed.
- Tour on medical ground outside state: Tour on medical ground outside state may be granted (0) if referred from Govt. Hospital only and TA will be borne by JCI as per entitled class.
- In case of duration of prescribed medicine is not mentioned in the prescription or there is any (10)doubt about the treatment, the processing section may refer to the Doctor at Head Office (for HO only) and in case of ROs the same may be consulted with the Head Office Processing Section.
- In case of prolonged treatment like heart disease, diabetes, thyroid, hyper tension (HTN) etc. (11)medicines and next visit may be allowed upto 10(ten) days after completion of period of treatment.
- All the bills must be processed by the concerned section within 15(fifteen) working days (12)from the date of receipt of the bill.
- On implementation of the revised medical rules, the existing medical committee will be dissolved, as such, no special approval, henceforth will be entertained. (13)

All other orders issued earlier from time to time shall remain unaltered except above-noted changes.
