EXPRESSION OF INTEREST (EOI)

Sub: School Outreach Activities under Swachhata Action Plan (SAP) for Financial Year 2023-24

Background

The Jute Corporation of India Limited is a Central Public Sector Enterprise under the administrative control of the Ministry of Textiles, Govt. of India, incorporated in the year 1971, under the Companies Act, 1956. It is the nodal agency of the Govt. of India for carrying out Minimum Support Price (MSP) Operation in raw jute.

JCI, is mandated to undertake Swachhata Action Plan (SAP) activities in compliance with the directives of the Ministry of Textiles, Govt. of India. In this regard, the following activities is being undertaken by the Corporation under its SAP program for the Financial Year 2023-24, with the objective of improving the existing infrastructures/ facilities of Govt./Govt. aided schools with the financial assistance provided by JCI.

EOI

Proposals are being invited from Govt. Schools/ Govt. aided Schools/ Schools run by Charitable institutions for upgrading their existing infrastructure in relation to Swachhata / Cleanliness requirements.

Corporation's Obligation

Financial Assistance to selected schools for carrying out necessary repair and beautification work for upgrading existing infrastructure in relation to Swachhata / Cleanliness requirements, within the approved Budget.

Deliverables of the Selected Schools

To complete the approved repair and beautification job within the stipulated time.

To prominently display a banner depicting the name and logo of The Jute Corporation of India Ltd. in the vicinity of the repair and beautification job.

To preserve and share photographs / pictures evidencing the actual carrying out of the job.

Duration of the project-

The project must be completed within 2 months of the date of issue of approval letter from JCI.

Financial Assistance & Payment Terms

Financial Assistance of maximum up to Rs.2 lakhs for each school for the project to be released by the Corporation from its Swachhata Action Plan Budget for the Financial Year 2023-24, post successful completion of all the repairing & renovation activities and submission of bills by the school to the Corporation.

Reimbursement of the agreed amount and irrespective of the actual amount incurred by the school shall be made only through RTGS/NEFT in favour of the school.

No advance payment will be made by JCI.

No capital expenditure by the school is allowed for reimbursement.

A Permanent Account Number (PAN) of the school is mandatory, else TDS shall be deducted at the applicable rates.

Evaluation of the Proposals

The proposals will be evaluated by the Management of JCI, based on the merit and the need of the school, as elucidated by the school in its proposals which is to be duly supported by pictorial evidence. The decision of the Management in this regard shall be final.

A physical verification of the facility / infrastructure and other relevant aspects of the schools shortlisted for financial assistance under SAP may be undertaken by JCI, if needed, to assess the actual condition before approval of the project by JCI.

The total funds allocated may be split amongst the schools from where the proposals are received and the subsequent decision of the Corporation.

Last Date for Receipt of Proposals

The details of the repair and renovations/beautification works to be carried out along with the estimated expenditure proposals should be sent either by post/courier/in person in an envelope super-subscribed “**Applications under Swachhata Action Plan (School Outreach)**” 2023-24 to the following address by 30.06.2023 -
