- (A) Installation of GI Chain link fencing in the south end boundary of JTM premises.
- (B) Raw materials for installation of GI Chain link fencing in the south end boundary of JTM premises, must be provided by the party as per specifications mentioned below.
- (C) Specifications of GI Chain link fencing as follows:
 - 1. GI Chain link Rhombus shape approx. (2.5*2.5) Sq. Cm.
 - 2. Thickness of GI Chain link 14 to 10 Gauge (i.e. 2.0 mm. to 3.0 mm. thick), as per availability.
 - 3. GI Roll size as per market availability.
 - 4. Fencing height preferably 5'-6" minimum (approx..) from the Existing Ground Level. Ground bed to be freed 2" or 50.0 mm.
 - 5. GI Chain Make As per best availability in the local market.
 - Length of GI chain link fencing as per practical site requirement. Total portion of damaged / unavailable existing fencing need to be replaced / installed with new GI Chain link fencing.

- 7. Specification of materials as per the given standards needs be get certified from the officials before using.
- (D) Seen MS Angle section, as the existing vertical post.
- (E) Some Vertical postsare seen in bent / leaning condition w.r.t. the Ground. Those need to be straightened & to be kept aligned properly.
- (F) If seen that some MS vertical posts are missing from the Fencing line or completely damaged, new MS Vertical post need to be installed on that portion. Thenew Vertical Post should have Angle section of < (100* 100 * 8) mm. & it's Height to be matched with the Post(s) of both the sides of the new Angle.</p>
- (G) Make of the Angle TATA / SAIL / JINDAL.
- (H) All the vertical posts need to be jammed properly with Cement concrete (1:1.5:3 ratio), up to 150.0 mm. deep from the Gr. Level., before pulling GI chain link fencing. The nett excavation area shall be (8" *8").
- (I) All the MS vertical posts, need to be painted properly with 01 coat of oil bound primer (metallic primer) & 02 coats of syn. enamel paint, after proper, rubbing, cleaning, smoothening of the surfaces etc. Make ASIAN / BERGER / ICI / NEROLAC.
- (J) Any kind of small repairing, as required of the MS Angle vertical post, need to be done.
- (K) Pulling of GI chain link, to be done properly.
- (L) Fixing of GI chain link with MS post, to be done with GI nut, bolt & washer (with necessary shape, size).
- **Payment.** There will be no part/advance payment. Payment will be done on completion of work and after thorough inspection by office representative.
- **Mode of payment:** By online payment mode such as NEFT/RTGS etc. and within two weeks of completion of work.
