- 5. The sales confirmation (as specified in Clause) is the discretion of JCI Management -- in case multiple offers are received with equally quoted lot(s) on or above the indicative rate, then an equal distribution will be awarded among the bidders. In case multiple offers are received with variable quoted rates of lot(s) on or above indicative rates, then the highest lot(s) value quoted by the bidder will be awarded.
- 6. If the successful bidders fail to deposit 105% value of the awarded quantity within 5 working days from the date of issuance of the awarded quantity, then the EMD will be forfeited, and stock will not be given to the successful bidder.
