The Annexure duly filled are to be submitted in two separate sealed envelopes superscribed 1)Technical Bid containing Annexure B along with proof of Earnest Money Deposit (EMD) and 2) Price Bid containing Annexure C. Both the envelopes are then to be kept in another sealed envelope superscribing Tender No. & "Sale of Loose jute & Rope under Kolkata RLD Region" addressed to the Regional Manager, Kolkata RLD, The Jute Corporation of India Limited along with name and address of the Tenderer. Completed bids in all respect should be dropped in tender box kept in our JCI Kolkata RLD Regional Office, 15N,Nellie Sengupta Sarani, Hudco Building 7th Floor, Kolkata-700087.
- 2. The Technical Bid of the tenders will be opened first and then the Price Bid of only those tenders will be opened who qualify in the Technical Bid.  Each tender is to be accompanied with Earnest Money Deposit in the form of NEFT/RTGS/UPI only in the name of Jute Corporation of India Limited in the bank account specified earlier. Cheques/ Demand Drafts will not be accepted. In the event of tenders not being accepted the deposited amount will be refunded to the unsuccessful bidder after finalization of the tender without interest. No Tender will be considered without Earnest Money Deposit.

On contract being awarded, the EMD of the successful bidder will be converted into performance security deposit and the Performance Security Deposit shall be released to the bidder after completion of the contract period only and on being satisfied of the successful completion of the contract and ensuring that no liabilities are due from the bidder. In case of any complaint or pending dues, the Performance Security Deposit shall be released only when the said due(s) is cleared by the bidder and/or when the complaint is resolved. The Performance Security Deposit will not carry any interest amount.

- 2. Reference to any other deposits with The Jute Corporation of India Limited shall not be considered as EMD for this Tender.
- 3. The Tender offer shall be valid for a period of three months from the date of opening of the tender.
- 4. The successful Tenderers will be intimated after finalization of tender. Lifting Order shall be issued to the successful bidder and he should lift the stock after **making full payment in advance**. The Tenderers should make their own arrangements at their own cost to clear and lift the materials during normal working hours from the DPCs of JCI under Kolkata RLD Region (As per Annexure-A).
- 5. The successful Tenderers will have to pay the full sale value within 5 (Five) days of intimation of the Lifting Order and remove the materials from our DPC's within 10 (Ten) days of acceptance of the Lifting Order.
- 6. In case of delay in depositing the full amount of the accepted offer within the stipulated period, interest / penalty may be levied or EMD may be forfeited for the balance amount for the delay period at the discretion of the Corporation without any further reference / notice to them and the materials would be resold by us at our discretion.
- 7. The Corporation does not bind itself to accept the highest offer and reserves the right to accept or reject any or all tenders either in whole or in part and the Corporation will have the right to split up and divide the sale order amongst the Tenderers at its discretion.

12. DISPUTE RESOLUTION & GOVERNING LAWS

Any dispute, differences or controversy of what so ever nature between the parties arising out of or in relation to this Tender, the dispute shall in the first instance be attempted to be resolved amicably through discussions/negotiations between the parties. Further, all questions, disputes and/or differences arising under or in connection with this Tender or touching or relating to construction, meaning, scope, performance, operation or effect of this Tender or the validity or the breach thereof, which is not resolved amicably within 15 days, such matter or matters shall be referred for Arbitration. The Arbitrator (other than the employee of the parties hereto) shall be a Sole Arbitrator to be mutually appointed by both parties within a period of 15 days, failing which the sole Arbitrator shall be appointed as per the provisions of the Arbitration and Conciliation Act 1996 as amended and the decision/ award of the Sole Arbitrator shall be final and binding upon the parties hereto. The language of the arbitration shall be English, and the seat of the arbitration shall be at Kolkata.

In case the award passed by the arbitrator, is assailed/ referred before the court of law, the same shall be exclusively subject to the jurisdiction of Courts at Kolkata.

This Tender shall be interpreted and constructed in accordance with Indian laws and only the Courts at Kolkata shall have exclusive jurisdiction over any matters arising out of this Tender.
