This has reference to Tender Notice No. JCI/RO/BDK/Old Raw Jute Sale/2025-26/01 dated 24.12.2025 and subsequent note sheet dated 13.01.2026 regarding extension of the tender. It is submitted that till date 21.01.2026, no documents expressing interest have been received against the above-mentioned tender. Upon review, the RO Tender Committee observed that the stock of old raw jute is scattered in small quantities at different DPCs, which may be a possible reason for poor buyer response.

In order to generate better market interest and to ensure quick and timely disposal of stock, The RO Tender Committee proposes to consolidate all bales at a single location, i.e., Kendupatna DPC, by shifting bales from Bhadrak DPC and Danpur DPC.

Proposed Shifting of Bales:

From the rate received it is ascertained that the additional transportation cost of Rs. 8,000/- (Rupees Eight Thousand only) will necessitate a proportionate revision in the base price per quintal of the already floated tender.
